## THE STANDARD BANK OF SOUTH AFRICA LIMITED (STANDARD BANK/WE/US/OUR) TERMS AND CONDITIONS (TERMS) IN RESPECT OF THE CREDIT CARD SPEND AND WIN R100 000 COMPETITION (COMPETITION)

## 1. **DURATION**
